



How the Criminal Justice Law Enforcement Automated Data Services System Works

CJLEADS is being developed as a tool for criminal justice professionals to support effective decision making. This program offers the advantage of bringing together criminal justice information from multiple systems to create a clearer picture of an individual. The following demonstrates how a criminal justice professional can search for information.

1. An authorized criminal justice professional logs into the system through a secure web-based interface and inputs search criteria.
2. Search results display summary information about individuals who meet the search criteria. Role-based security determines the information to display in support of the criminal justice professional's defined business needs.
