STATE CONTROLLER DAVID MCCOY TO EXPAND THE CJLEADS CRIMINAL-TRACKING DATABASE TO JOHNSTON, HARNETT, WAYNE, SAMPSON, CUMBERLAND AND DUPLIN COUNTIES

State Controller David McCoy will expand the CJLEADS (Criminal Justice Law Enforcement Automated Data Services) criminal-tracking database to Johnston, Harnett, Wayne, Sampson, Cumberland and Duplin counties with regional kick-off meetings June 1st, 2nd and 3rd at the following locations:

- **Wednesday, June 1 – NC Justice Academy, East Campus, 200 West College Street, Learning Resource Center (Building 5) Classroom #13, Salemburg.** (NOTE: This kick-off meeting includes Sampson, Cumberland and Duplin counties.) **Media availability will be at 9:45 a.m. and 1:15 p.m.**
- **Thursday, June 2 and Friday, June 3 – Johnston Community College, 245 College Road, Public Safety Building, Room J1470, Smithfield.** (NOTE: This kick-off meeting includes Johnston, Harnett and Wayne counties.) **Media availability will be 9:45 a.m. and 1:15 p.m. June 2; and 9:45 a.m. June 3.**

(During the media availability, media will have the opportunity to interview Controller McCoy and/or local criminal justice professionals in attendance about the program. Please note that because of security requirements, only criminal justice professionals can view the live data contained in CJLEADS. However, media can get a separate demonstration of CJLEADS that contains “test” data at the kickoff meeting or by going to http://www.osc.nc.gov/cjleads/NCCJLeads_Demo_rev02.swf.)

Joining Controller McCoy at the regional kick-off meetings are area legislators as well as criminal justice professionals (law enforcement officers, district attorneys, judges, magistrates and clerks) in the respective counties. At each of these meetings OSC will provide a demonstration of CJLEADS that will show the potential and benefits of this important new tool. In addition, OSC will coordinate training schedules with the local criminal justice organizations. Criminal justice professionals can begin to use CJLEADS after completing the training class.

Phase II Begins

After the Wake County pilot was completed, OSC began rolling out CJLEADS statewide in three phases. Phase I rollout to the Upper and Lower Piedmont was conducted in Winter 2010/2011. Phase II began May 17 with kickoff meetings scheduled in the lower western and lower eastern regions of the state.

Additional upcoming Phase II kickoff meetings include:

- June 7, 2011 – Henderson, Transylvania, Polk, Rutherford counties, Hendersonville Police Department, Hendersonville, NC
- June 8, 2011 – Cherokee, Clay, Graham counties – Tri-county Community College, Murphy, NC
- June 9, 2011 – Macon, Swain, Jackson counties – Southwestern Community College, Franklin, NC
- June 21-22, 2011 – Columbus, Robeson, Bladen counties – Southeastern Community College, Whiteville, NC
- June 22-23, 2011 – New Hanover, Brunswick, Pender counties – Cape Fear Community College, Castle Hayne, NC
- June 28, 2011 – Onslow and Carteret counties – Coastal Community College, Jacksonville, NC
- June 29, 2011 – Craven, Pamlico, Lenoir, Jones counties – Craven County Sheriff's Office, New Bern, NC

Background

The Office of State Controller deployed the CJLEADS program to Wake County as a pilot in July, 2010. As of today, over 6,000 users, comprising criminal justice organizations with an operational presence in Wake County as well as counties located in the Phase I rollout, are established in CJLEADS and are training or currently using the application. (These Phase I counties included: Durham, Orange, Person, Caswell, Chatham, Guilford, Hoke, Moore, Montgomery, Richmond, Stanly, Cabarrus, Mecklenburg, Gaston, Lincoln, Cleveland, Rockingham, Stokes, Forsyth, Davidson, Rowan, Randolph, Alamance, Lee, Scotland, Anson and Union.)

The program is integrating data found within the state's various criminal justice applications and is providing up-to-date criminal information in a centralized location via a secure connection for use by state and local government criminal justice professionals. CJLEADS has two primary objectives: to provide a comprehensive view of an offender through a single application, allowing for positive identification of an offender through a photographic image; and to provide an "offender watch" capability to alert criminal justice professionals when an offender has a change in status. CJLEADS replaces the manual process of looking up historical criminal data from multiple systems, reduces the risk of overlooking critical data and improves the information needs of law enforcement agencies.
