
RALEIGH – For May 2014, when compared to the prior year through May 2013, North Carolina experienced a decrease in General Fund receipts which includes tax and non-tax receipts. Tax revenues decreased by \$215.4 million, or 1.2 percent, and non-tax revenues decreased by \$92 million, or 8.5 percent as compared to the previous year.

The General Fund’s unreserved fund balance as of May 2014 was \$291 million as compared to \$553.1 million as of May 2013.

The Office of the State Controller serves as an independent resource to ensure the financial integrity of the State by providing accounting, disbursing, payroll, internal control, data management, eCommerce and financial reporting systems that serve state agencies, employees and the public and by maximizing financial return through its statewide cash management plan. The OSC issues numerous financial reports including: General Fund Monthly Financial Report, IT Expenditures Report, Statewide Accounts Receivable Report, the State's Comprehensive Annual Financial Report (CAFR) as well as the short, easy-to-read version of the CAFR known as the "popular" report.
